#### 1.0 Introduction

Joint Medical Store (JMS) Private-not-for-Profit organization established by the Uganda Catholic Medical Bureau (UCMB) and the Uganda Protestant Medical Bureau (UPMB) in 1979 as the Logistics & Supply Chain Arm of the medical bureaus. It is ISO 9001:2015 certified and registered as a corporate body under the Trustees Incorporation Act Cap 165. JMS' mission is to supply Quality Affordable Health solutions in an efficient manner ensuring the sustainability of the Member Health Units.

The National Medicines Policy 2015-2020 recognizes JMS as the mandated warehouse for commodities designated for all faith-based Private Not for Profit Organisations (PNFPs) in Uganda through various structural and administrative frameworks such as MOUs, government direction, and global arrangements.

JMS operates under license by the National Drug Authority (NDA) and in close collaboration with the Ministry of Health and agencies that include: USAID; Global Fund; and UNFPA. JMS operates in line with the regulations and guidelines established by government agencies such as the NDA, URA, UNBS, and local governments. JMS network of beneficiary health facilities includes but is not limited to those under the coordination of the four medical bureaus: UPMB, UCMB, UOMB, and UMMB.

the deadline. Any modification received after the deadline shall be deemed late and will NOT be considered.

(iii) Amendments (including extensions of the due date and time for submission of offers):

At any time prior to the due date and time for the submission of offers/proposals, JMS may alter the RFP by issuing written amendments. Any amendment thus issued shall become part of the RFP and will be sent to all known recipients of this RFP. Firm and or individual shall acknowledge receipt of any such amendment in their offer. To give prospective firm and or individual reasonable time in which to take the amendment into account when preparing their offers, JMS may extend the due date and time for submission of offers.

## 7.0 Language

The offer/proposal as well as the correspondence and documents relating to the offer/proposal shall be in English.

### 8.0 Validity

Offers/Proposals shall remain valid for **60 days** from the due date for receipt of offers. In exceptional circumstances, prior to expiry of the original offer validity period, JMS may request that the firm and or individual extend the period of validity for a specified additional period. Firm and or individual agreeing to the request will not be required to otherwise modify their offer.

### 9.0 Questions and Clarifications

All information gathered and shared during these sessions will be anonymized and answers shared with all Bidders.

### 10.0 Evaluation criteria

The evaluation shall be conducted in accordance to the highest bidder in each lot

## 11.0 Confidentiality and Integrity

- a. Information relating to the evaluation of proposals, outcome of the RFP and recommendation of contract award(s) shall not be disclosed to Bidders or any other persons not officially concerned with such process. Bidders will be informed whether they have been awarded a contract once the tender process is completed;
- b. Any attempt by a Bidder to influence JMS and in the evaluation of proposals or contract award decisions shall result in the rejection of the Bidder's proposal;

#### 12.0 Award Process

## a. Right to Accept or Reject any or All Proposals

JMS reserves the right to accept or reject any bid, or cancel this entire RFP or part of the RFP and reject all Proposals at any time without thereby incurring any liability to the affected firm and or individual. Information relating to the examination, clarification, evaluation of responses shall not be disclosed to responders or any other persons not officially concerned with this process.

Any effort by the responder to influence Joint Medical Store or any of its employees in the evaluation, bid comparison, may result in the rejection of the offer.

### b. Clarification of Offers:

During evaluation of the offers, JMS may at its discretion, ask for a clarification on the bid responses.

## 13.0 Negotiations

- (i) Negotiations will be conducted fairly and with all firm and or individual in the competitive range.
- (ii) Firm and or individual that are not within the competitive range will be notified by Joint Medical Store.
- (iii) Firm and or individual that fail to provide the requested information in this RFP and are not falling within the competitive range will be notified by Joint Medical Store.

### 14.0 Notification to Unsuccessful Firm and or individual

Upon completion of award, Joint Medical Store will promptly notify each unsuccessful firm and or individual.
